

**AN ACT TO AMEND § 80.72(b) OF ARTICLE 5,
CHAPTER 80; AND TO AMEND §§ 85.10 AND 85.14,
AND TO ADD A NEW § 85.61 TO CHAPTER 85, ALL OF
TITLE 9, GUAM CODE ANNOTATED, RELATIVE TO
IMPROVING THE GUAM PAROLE BOARD
PROCESSES.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the number of persons applying to the Guam Parole Board for parole has
4 increased significantly in the past several years. The Guam Parole Board has been
5 inundated with parole requests. Parole requests made by the same person annually

1 are rejected every year due to the circumstances of the crimes and based upon the
2 Guam Parole Board's review and application of the law to these requests.

3 These parole requests and hearings are traumatic for the victims of violent
4 crimes, and the loved ones of the victims of violent crimes, and re-victimize them.
5 Serial parole requests by violent offenders require the victims and loved ones of
6 victims to appear at parole hearings every year to oppose or object to the parole
7 requests. *I Liheslaturan Guåhan* finds that the serial, annual parole requests require
8 the victims of violent crimes, and their loved ones, to relive the pain and trauma of
9 the victims' deaths or injuries and to experience the loss and grief over losing their
10 loved ones every year, year after year. Many of the victims and their loved ones
11 travel long distances to attend the parole hearings and the stress of travel is added on
12 top of the already difficult circumstances. *I Liheslaturan Guåhan* finds that persons
13 imprisoned for violent crimes who have applied for parole and who have been denied
14 parole for two (2) consecutive years should not be eligible to apply for parole again
15 for at least four (4) years from the date of denial of the last parole request in order to
16 spare the victims and their loved ones further trauma, pain and grief.

17 In addition, current law provides that the board consists of seven (7) members,
18 requiring a quorum of four (4) to meet and make decisions. The Guam Parole Board
19 is comprised of members who sit on the board on a volunteer basis, which makes it
20 more difficult for members to attend full-day meetings when they have jobs, become
21 sick, or go off-island. This has resulted in great difficulties in obtaining the number
22 of persons necessary for a quorum, resulting in backlogs and delays in determining
23 the parole applications. *I Liheslaturan Guåhan* finds that when the previous law,
24 which allowed for five (5) members and a quorum of three (3) was in effect, the
25 board had less difficulty obtaining a quorum or having backlogs of undetermined
26 parole applications.

1 Crime victims and families of victims have rights under the Crime Victim's
2 Rights Act of 2004. *I Liheslaturan Guåhan* finds that the rights of crime victims and
3 their families extended in 8 GCA Chapter 160 are necessary to ensure that they are
4 treated with dignity, respect, courtesy and sensitivity, and that their safety is
5 prioritized.

6 **Section 2.** § 80.72(b) of Article 5, Chapter 80, Title 9, Guam Code
7 Annotated, is hereby *amended* to read:

8 “(b) The Board *shall* consider the desirability of parole of each inmate
9 at least sixty (60) days prior to his/her first eligibility. Following such
10 consideration, the Board *shall* issue a formal order granting or denying parole.
11 If parole is denied, the Board *shall* state in its order the reasons therefor and
12 the approximate date of next consideration, which *shall not* be more than one
13 (1) year from the date of the previous consideration, except that if a person
14 imprisoned for the commission of a violent crime has been denied parole by
15 the Board for two (2) consecutive years, the Board *shall* set the next
16 consideration four (4) years from the date of the previous consideration. Said
17 person *shall not* be eligible for parole again for at least four (4) years after the
18 date of the last denial of parole. The Board need not state any reasons for
19 denial if to do so would impair a course of rehabilitative treatment of the
20 inmate.”

21 **Section 3.** § 85.10 of Chapter 85, Title 9, Guam Code Annotated, is hereby
22 *amended* to read:

23 **“§ 85.10. Guam Parole Board Created.**

24 (a) There is in the Executive Branch of the government of Guam, a
25 Guam Parole Board, hereinafter referred to as the Board, consisting of five (5)
26 members appointed by *I Maga'låhi* [the Governor], by and with the advice
27 and consent of *I Liheslatura* [the Legislature]. Only persons, who by their

1 knowledge and experience are prepared to perform efficiently the duties of
2 the Board as hereinafter provided, shall be eligible for such appointment. Any
3 person holding an elected office *shall not* be eligible to serve on the Guam
4 Parole Board. No person who has a family member of the first consanguinity
5 serving a local sentence, or on parole, shall be eligible to serve on the Board.

6 (b) The composition of the Board members *shall* be comprised of the
7 following, with the minimum background and experience:

8 (1) at least one (1) Board member *shall* have at least five (5)
9 years of experience in law enforcement or other criminal justice work,
10 or a baccalaureate degree in criminal justice from a college or university
11 accredited by a United States accrediting body recognized by the
12 Council on Higher Education Accreditation (CHEA) or its successor,
13 or an equivalent foreign university as determined consistent with 17
14 GCA § 3104(a)(1), or professional experience in these areas of study;

15 (2) at least one (1) Board member *shall* have at least a
16 baccalaureate degree or higher in social work, sociology or psychology,
17 or a medical degree from a college or university accredited by a United
18 States accrediting body recognized by the Council on Higher Education
19 Accreditation (CHEA) or its successor, or an equivalent foreign
20 university as determined consistent with 17 GCA § 3104(a)(1);

21 (3) at least one (1) Board member *shall* have at least five (5)
22 years of experience in human resources development, or legal
23 background or professional experience in these areas of study;

24 (4) at least two (2) Board members *shall* come from the public
25 at-large; and

26 (5) all Guam Parole Board members *shall* be of good moral
27 character.”

1 **Section 4.** § 85.14 of Chapter 85, Title 9, Guam Code Annotated, is hereby
2 *amended* to read:

3 **“§ 85.14. Chairperson Appointed: Meetings at Least Monthly.**

4 The Board *shall* elect a chairperson from among its members. The
5 chairperson *shall* be elected by its members every two (2) years. The Board
6 *shall* meet regularly at least once a month. Special meetings may be called by
7 the chairperson. Not less than three (3) voting members present *shall*
8 constitute a quorum for the transaction of business, and the affirmative vote
9 of three (3) members present *shall* be required to make any action of the Board
10 valid. No action *shall* be taken by the Board at any meetings or hearings,
11 unless a quorum is present. The election for chairperson from among its
12 members *shall* follow upon enactment of this Act.”

13 **Section 5.** A new § 85.61 of Chapter 85, Title 9, Guam Code Annotated, is
14 hereby *added* to read:

15 **“§ 85.61. Adherence to Crime Victim’s Rights Act of 2004.**

16 Pursuant to 8 GCA Chapter 160, also known as the Crime Victim’s
17 Rights Act of 2004, the Board and Parole Officers *shall* adhere to all of their
18 responsibilities and honor all of the rights afforded to victims as outlined in
19 the Chapter.”

20 **Section 6. Severability.** If any provision of this Act or its application to any
21 person or circumstance is found to be invalid, or contrary to law, such invalidity
22 *shall not* affect other provisions or applications of this Act that can be given effect
23 without the invalid provision or application, and to this end the provisions of this
24 Act are severable.

25 **Section 7. Effective Date.** This Act *shall* become effective upon
26 enactment.
