Dear Speaker Terlaje:

Thank you for the opportunity to provide a submission of potential projects for American Rescue Plan funding to the Guam Legislature. We have provided a listing of potential projects on the spreadsheet attached. As you can see, there many potential uses for the funds and we are unclear on any restrictions that may be tethered to the funds.

The University of Guam supports any amount that can be spared to bolster the Student Financial Aid Program. \$1.2 million would bring the University to the amount initially sought in the original budget filing.

UOG has secured \$8 million grants and \$21 million in other funding to construct facilities that support critical areas such as nursing, engineering, and freshwater resources research and water quality testing and student success. We have construction shortfalls of \$3.8 million and are in need of funding for a construction management contract in the amount of \$1.5 million. We would also welcome support for laboratory equipment, classroom and laboratory furniture, generators, nursing beds, and simulation mannequins for nursing training. \$1.3 million and \$1.07 million in investments in these critical need areas would represent an investment in Guam's students.

Other investments in education at all levels across GDOE, GCC, and UOG will return high yields in terms of dollars, tax revenues, reversing the brain drain, providing opportunities for our own people, and enriching our lives and community.
