Attached is a petition from FHP Health Center and TakeCare Insurance Company, Inc. employees asking you to not pass Bill 112-36 in its current form.

While we agree that the Medical Malpractice Mandatory Arbitration Act ("MMMAA") on Guam needs revision, Bill 112-36 is not a better alternative.

Bill 112 is bad healthcare policy that will harm the healthcare industry on Guam.

Through our analysis of the legislation, Bill 112-36 will increase our medical malpractice premiums, will increase the fees for services FHP Health Center provides its patients, and will increase the premiums TakeCare charges its members for health insurance.

Guam is already short of health care providers, nurses and other health professionals. We are always looking for more doctors and providers at FHP Health Center. This bill will make it more difficult if not impossible to look for providers and specialist to move and practice in Guam. If an off-island doctor was leaning toward moving to Guam, Bill 112-36 will push that doctor to change their mind due to the increased medical malpractice insurance and threat of increased litigation.

Please do not pass Bill 112-36.
